**AUTHORIZING THE CITY OF SYLVANIA TO ISSUE CHECKS FOR  
REIMBURSEMENT TO SYLVANIA TOWNSHIP AND THE CITY OF  
SYLVANIA RELATIVE TO PAYMENTS FOR PUBLICATION OF NOTICES  
AND PURCHASE OF LIABILITY INSURANCE COVERAGE ADVANCED ON  
BEHALF OF THE BOARD OF DIRECTORS OF THE SYLVANIA TOWNSHIP  
CITY OF SYLVANIA JOINT ECONOMIC DEVELOPMENT DISTRICT**

**WHEREAS**, the Board of Directors of the Sylvania Township City of Sylvania Joint Economic Development District (“Board”) voted on December 21, 2020, to approve contracts for liability insurance for the Board from Stapleton Insurance Group, and the funds for the purchase of such insurance were advanced by the City of Sylvania (“City”) in the amount of \$2,793; and

**WHEREAS**, the Board directed that various legal notices of the passage of resolutions of the Board be published as required by Ohio law, and funds for publication of legal notices were advanced by the City in the amount of \$123.12, and by Sylvania Township (“Township”) in the amount of \$118.56; and

**WHEREAS**, the existing Contract For Tax Collection, Administration, and Enforcement between the City of Sylvania, Ohio, and the Board (“Tax Collection Contract”) directs City to issue minor, miscellaneous expenditures for the Sylvania Township City of Sylvania Joint Economic Development District, including check writing:

**NOW THEREFORE, BE IT RESOLVED** by the Board of Directors of the Sylvania Township City of Sylvania Joint Economic Development District

The Finance Director of the City of Sylvania be, and he hereby is, authorized and instructed to issue reimbursement checks as follows: \$2,916.12 to the City of Sylvania for payment of insurance premiums and publication of legal notices; and \$118.56 to the Board of Township Trustees of Sylvania Township for the publication of legal notices.

**BE IT FURTHER RESOLVED**, that it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.
